§1 Contract Subject

- (1) By signing this contract, the bidder submits a **binding bid** for an advertising space at **AERO 2025 Friedrichshafen**.
- (2) The bidder agrees to pay the full amount of their highest valid bid on time if awarded.

§2 Auction Conditions

- (1) The **auction ends 3 weeks before the event begins**.
- (2) The current highest bid per quadrant will be considered the **winning bid**.
- (3) The advertising space will only be realized if the **minimum auction revenue of €3,000** is reached.
- (4) Each new bidder must outbid the previous bid by **at least €100**.

§3 Binding Nature of Bids

- (1) Each submitted bid is **legally binding** and **cannot be withdrawn**.
- (2) If the bidder holds the highest bid for their quadrant at the end of the auction, they are obligated to pay the full amount.

§4 Payment Terms & Consequences of Non-Payment

- (1) The invoice will be sent via email after the auction ends.
- (2) The bidder agrees to transfer the amount **within 7 days** of receiving the invoice.
- (3) If payment is not made, the amount will be **legally enforced**.
- (4) If the original highest bidder fails to pay, the organizer reserves the right to transfer the bid to the next highest bidder.

§5 Refund & Cancellation

- (1) If the flight is not conducted for reasons attributable to the organizer, a full refund will be issued.
- (2) **No refund** will be issued if the bidder fails to pay after the auction ends or otherwise attempts to withdraw from their obligation.

§6 Requirements for the Advertising Logo

- (1) The bidder commits to uploading a **high-quality logo**.
- (2) If the logo is not in a suitable format, it will be adjusted in consultation with the bidder.
- (3) The bidder ensures that they **own all rights** to the uploaded logo.

§7 Disclaimer of Liability

- (1) The organizer assumes **no liability** for damages resulting from the use of the advertising space.
- (2) If the uploaded image **infringes third-party rights**, the bidder alone is liable.
- (3) Before the event, the bidder must provide a **statement of rights usage approval**.

§8 Miscellaneous Provisions

- (1) Changes to this contract require **written agreement from both parties**.
 - (2) The place of jurisdiction is Baden-Baden, Germany.
 - (3) By providing their **electronic signature**, the bidder acknowledges all terms as **binding**.
